^{′о}оноs) In accordance with the School Education Act 1999, schools are required to determine and outline the anticipated financial costs of the educational programs at the school.

The West Leeming Primary School Board has approved the following schedule of Voluntary Contributions and Charges for 2025.

1. VOLUNTARY CONTRIBUTIONS - \$60.00 per student

Funds raised through contributions allow us to enhance the learning environment at West Leeming Primary School through purchasing resources and running programs to benefit all students. While contributions are voluntary, the quality of our learning programs will be maximized when all families contribute.

2. CHARGES FOR OPTIONAL ACTIVITIES

Optional charges are listed below for each year group. This is for your child's incursions and excursions throughout the year. You can choose to pay bulk monies at the beginning of the year or on an event basis. Notes or permissions slips will be sent home for each activity as it approaches, and you will be asked to make payment prior to your child participating in that activity. Parents have the option to make a bulk payment at the commencement of the year to cover the cost of these activities. Any funds left at the end of the year will be rolled into the following year. This is the preferred method of payment and is intended to be more convenient for parents.

Please note that these are anticipated activities and charges and not a guarantee that they will occur.

PAYMENTS

Payments for voluntary contributions, charges in advance, and approved voluntary requests can be made at the beginning of the school year. Families have the option to make weekly, fortnightly, or monthly payments into their child's account to cover upfront charges or on an event basis. Any credit remaining from the previous billing year will automatically roll over to student accounts for the upcoming school year, reducing the total amount due. Payments can be made via EFTPOS, over the phone or at the front office or direct bank transfer to the account listed below. *Please note our bank details have changed.*
